

**SIBSAGAR COLLEGE, JOYSAGAR (AUTONOMOUS)
GUIDELINES FOR APPLICATION FOR Ph.D. SUPERVISORSHIP**

SUPERVISORSHIP

1.1. Eligibility criteria for appointment of Supervisor and Co-Supervisor

The following persons shall be eligible to be Supervisor for Ph.D. programmes relating to respective areas of specialization.

1.1.1. A permanent faculty member working as Professor/Associate Professor of the College with a Ph.D., and at least five research publications in peer-reviewed or refereed journals.

And/or

A permanent faculty member working as Assistant Professors in the College with a Ph.D., and at least three research publications in peer-reviewed or refereed journals.

Provided however, in case of not fulfilling the condition of research publications as mentioned above, proportionate weightage shall be given as per UGC norms.

1.1.2. Such recognized supervisors cannot supervise research scholars in other institutions, where they can only act as co-supervisors.

1.1.3. An expert of substantive reputation with evidence of research output other College/University Department/Centre/Institute/Organisation having PG programmes in concerned subject may also be recognized as the Co-supervisor under special circumstances on recommendation of the DRC concerned, provided – (i) he/she meets the eligibility criteria as prescribed by the Academic Council/Research Council from time to time and (ii) the College does

have an academic collaboration with that entity by way of a functional Memorandum of Understanding/Agreement (MoU/MoA).

1.1.4. In case of such prospective Supervisor/Co-supervisor from other College/University Department/Institute/Organisation having PG programmes in concerned subject, with whom the College does not have an academic collaboration by way of a functional Memorandum of Understanding/Agreement (MoU/MoA), the prospective Supervisor/Co-supervisor shall have to submit a No Objection Certificate from the competent authority of her/his own College/University Department/ Centre/Institute/ Organisation.

1.1.5. In case of topics which are of inter-disciplinary/multi-disciplinary nature where the Department concerned feels that the expertise has to be supplemented from outside, the DRC may appoint a Supervisor from the Department itself, who shall be known as the Supervisor, and a Co-Supervisor from outside i.e. other Department of the College/other College/University Department//Centre/other Institute/other Organisation etc. having PG programmes in concerned subject on such terms and conditions as may be specified and agreed upon by the consenting College/University Department//Centre/other Institute/other Organisation.
